SI. No. GENERAL CONDITIONS

1. The total number of section of the school shall be restricted to 20 (As per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.
2. Compliance of the points no. 1 to 3 may be submitted within 03 months on the SARAS Portal, failing which due action will be taken.

SI. No. CONDITIONS FOR COMPLIANCE

1. The school is also required to restrict student's upto 32 in each room (400 Sq. ft.) and further construct class room of minimum 500 Sq. ft. in future
2. The school is required to maintain well equipped Science Labs as per norms.
3. The school is required to maintain labs as per Chapter 4 rule 4.2 of Affiliation Bye Laws -2018

The above is subject to fulfillment of the following conditions:-

1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
